

1 Tabular Summary of BCFPI Questionnaires

- The next page tabulates sections in BCFPI Parent Questionnaires
- It is provided as an overview of Questionnaire scope, for initial orientation, and ongoing reference, when needed
- Readers are not expected to ‘master’ the detail of this table, and do not need to do so, in order to use or understand BCFPI
- The table on the next page lists ~ 28 sections /scales which may be used in V2 Parent Questionnaires.
 - These are listed in a column, under ‘Scale’, at the left side of the table
 - The meaning of each the scales and sections are described in [BCFPI Mental Health, Functioning and Risk Scales, and Descriptive Sections](#)
 - Only a subset of these are used for any specific questionnaire, based on age and purpose
- The columns in the left-center section show 4 categories for ‘Age of the child when data collected’
 - V2 questionnaires were normed for each of these age groups
 - Questionnaires corresponding to these age groups have some unique, and some common scales
 - Each has unique norms (the questionnaire for 6-19 yrs. has a shared set of scales and items, but unique norms, for ages 6-12.99 yrs. and 13-19 yrs.)
 - The software auto-selects the appropriate age-based questionnaire, based on the child’s age when the data is collected
- The columns at the right of the table show the 5 stages/purposes of services applicable to a given questionnaire
 - The user selects the desired stage/purpose when creating a new questionnaire for a case
- The numbers in the table under ‘Age when data collected’ indicate how many items are in each scale, if that scale is used for that age group
- The letters ‘C’, ‘I’ and ‘B’ under ‘Stage/Purpose’ indicate if the scale is used for Checklist, Interviews, or Both
- Each is available for questionnaires having scales suitable 5 Stages/Purposes of Service
